# What is COST Programme?

COST (the European Cooperation in Science and Technology) is an EU-funded programme which enables researchers and innovators to set up interdisciplinary research networks in Europe and beyond. We provide funds for organising conferences, meetings, training schools, short scientific missions and other networking activities on a wide range of scientific topics.

By creating open spaces where people and ideas can grow, we are unlocking the full potential of science. COST does not fund research itself but provides support for networking activities carried out within COST Actions.

COST invites researchers from all over the globe to create networks of researchers by forming in Europe and beyond to submit proposals for COST Actions through a continuous open call, no matter what their field of interest.

# What is COST Action?

Since its creation, COST has operated according to one main instrument, the COST Action.

## A COST ACTION IS A NETWORK:

- welcoming researchers and innovators;
- collaborating in fields of science and technology of common interest to at least seven COST Members/ Cooperating Member\* and additional partners from non-COST members;
- based on a joint work programme lasting four years;
- answering to the COST open call for proposals.

## A COST ACTION IS OPEN TO:

- all fields of science and technology (including interdisciplinary and new and emerging fields);
- all types of institutions (academia, public institutions, SME/industry, NGO, European/ international organisations, etc.);
- all career stages (both young and experienced researchers and innovators);
- all COST Members, as well as COST Near Neighbour Countries\* and Third States (International Partner Countries)\*. Participants in those countries can take part in all networking activities.

## BENEFITS OF PARTICIPATION:

**Scientific:** work on emerging scientific topics, maximising the production of new knowledge and breakthrough discoveries, international recognitions, co-publication, facilitating access to research infrastructure including databases.

**Networking:** connectedness, common projects, identifying potential partners for future collaboration.

**Mobility, visibility.**

**Career advancement** and opportunities for training.

**Financial support:** COST NNCs\* are eligible for COST funding, Third States\* have limited financial support, a COST Partner member\* provides national funding.

## Networking tools

### MEETINGS, WORKSHOPS AND CONFERENCES



These are organised by Management Committees (MC) in any COST Member participating in the network. They may be open to the wider community and provide opportunities to enhance the COST Action's visibility.

### TRAINING SCHOOLS



They offer intensive training on an Action topic at the premises of one of the participating institutions from any participating countries.

### SHORT-TERM SCIENTIFIC MISSIONS (STSMS)



These are exchange visits between researchers in the network which enable scientists to visit an institution or laboratory in another participating country.

### DISSEMINATION ACTIVITIES



COST encourages and supports Action participants to disseminate the outcome of their research to other COST networks, the wider scientific community, policymakers, the media, and society at large, through publications, on-line media, news releases, events, success stories, etc.

### VIRTUAL NETWORKING GRANTS



These are two types of grants:

- Virtual Networking Support (VNS) Grants: aimed at promoting virtual collaboration to complement traditional ways of collaboration within the research and innovation communities;
- Virtual Mobility (VM) Grants: aimed at strengthening the existing networks by allowing researchers to foster collaboration in a virtual setting, to exchange knowledge, learn new techniques, disseminate, and share Action results.

## Who can participate?

Researchers and innovators from universities, public and private institutions, NGOs, industry and SMEs.

Researchers from Near Neighbour Countries and Third States/International Partner Countries are also welcome to participate in COST Actions.

## Third States (International Partner Countries)

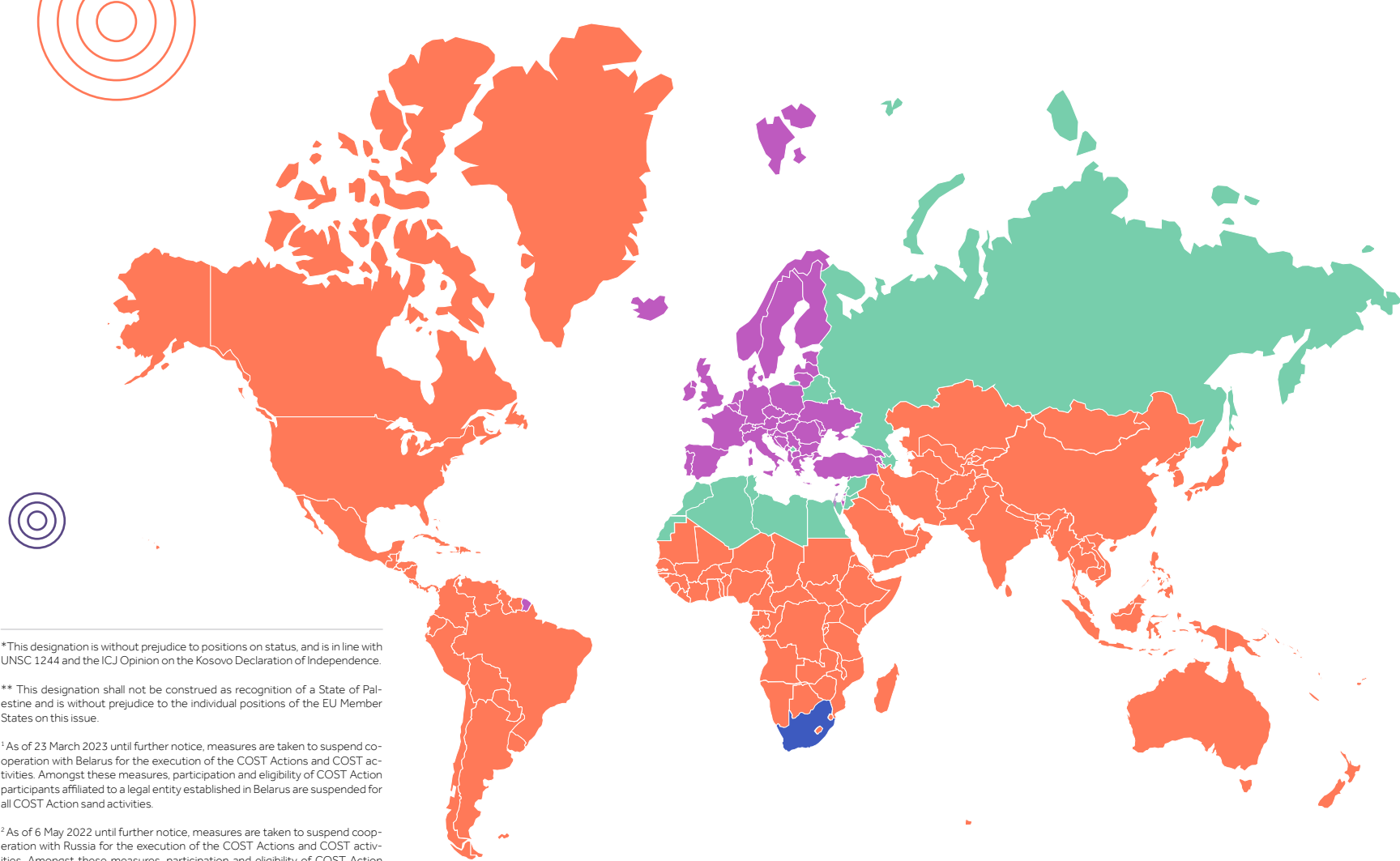

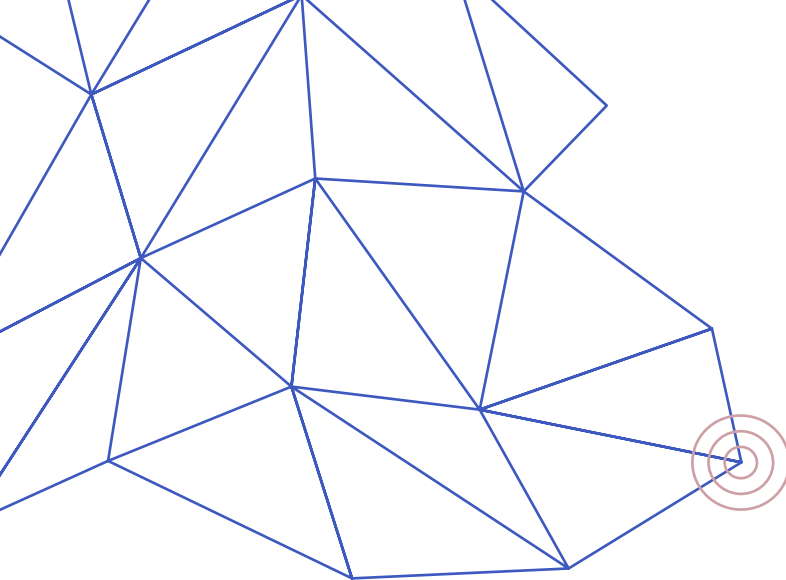
